

ChangeFest 2024 Artwork Expression of Interest

Expression of Interest closes 5pm 30 October 2023

About the Expression of Interest

Hands Up Mallee, Connected Beginnings Mildura and Collaboration for Impact invite applications from local Aboriginal and/or Torres Strait Islander artists to licence an artwork piece for use for the ChangeFest 2024 event.

ChangeFest 2024 will be held on Latje Latje country (Mildura), 20-22 March 2024. Over 500 delegates from around Australia are expected to attend.

Each year, the ChangeFest host location sources a local piece of Aboriginal and/or Torres Strait Islander artwork to be used to sit alongside the main branding of the event, and give a local identity for the event.

The artwork is a paid licencing/reproduction agreement and timelines will need to be met. An original or existing artwork can be used for the submission.

A non-exclusive licencing/reproduction agreement limited to 2 years will be entered into for the use of the artwork and its elements for the event. The artwork must be the property of the artist/s, not licenced elsewhere and is able to be used in this manner.

A once-off fee of \$4000 (excl. GST) will be paid to the successful applicant.

An appointed panel, made up of people reflecting our community, will make the decision on the winning application.

About ChangeFest 2024

ChangeFest is a nation-wide movement for place-based change. Every year, the movement gathers to learn, celebrate and strengthen the collaborative work of creating thriving and equitable communities across the country.

The fifth ChangeFest gathering will occur on Latje Latje country in 2024.

Those gathering for ChangeFest 2024 can expect:

- A culturally safe and welcoming event that will be grounded in community (voice and connection)
- Rejuvenating and supportive people and spaces
- A program that is designed to make people curious and reflective
- Knowledge sharing with practical tools, guidance and learning opportunities
- An experience that promotes and enhances the nation-wide movement for place-based change in Australia

People that attend ChangeFest are from a mixture of backgrounds and places, this includes:

- Community members
- Service providers
- Local, state and federal government
- Politicians
- Not-for-profits, non-government organisations etc
- Consultants

What we are looking for

We are seeking one local piece of artwork created by Aboriginal and/or Torres Strait Islander artist/s who live in and have a strong connection to our community. Applicants can come from either side of the river.

The artwork must:

- Reflect our place
- Celebrate our community's identity and connection
- Encompass our children, young people and families

The artwork will be used in incorporation with the ChangeFest 2024 logo.



A non-exclusive licencing/reproduction agreement limited to 2 years will be entered into for the use of the artwork and its elements for the event. The artwork must be the property of the artist/s, not licenced elsewhere and is able to be used in this manner.

The artwork and its elements will be used for the co-branding and local identity for the ChangeFest 2024 event in Mildura. This includes and is not limited to:

- · Websites and social media use
- Promotion of the event emails, marketing activities etc
- Media newspapers, TV, filming etc advertisements
- Promotional items (ie delegate bags, clothing, lanyards, water bottles etc)
- Brochures, programs, stationery etc
- Reports, presentations, publications, documents etc
- Event-related items such as posters, signage, presentation templates, name tags etc.
- Event-related downloadable phone App
- Event filming

Collaboration for Impact (CFI) is the national backbone organisation for ChangeFest and is partnering with local hosts Mildura. The selected artist will enter into a licensing agreement with CFI, and on behalf of all partners.

Respecting the artist and the artwork

A commitment is made to the appointed artist and artwork, that the artwork will not be used in an inappropriate, derogatory, degrading or offensive manner and the artist/s will be credited.

The artist will be acknowledged in promotional materials when and where appropriate.

The artwork will be digitised and used for co-branding for marketing and promotional purposes. ChangeFest works with Senior Graphic Designer Jordan Lovegrove from Ochre Dawn in South Australia.

Artwork specifications

The minimum size for the artwork is an A3 size (297 x 420mm).

The maximum size for the artwork is A1 (594 x 841mm).

The artwork is to be supplied in a 2-dimensional format that will then be converted to format/s that can be used for the event eg photographed and digitised.

The artwork is to be provided as an entire piece with the understanding that individual elements from the artwork may be created and used ie an icon.

Submissions

Applicants must address each of the following in their submission:

- Complete and return the submission form
- Outline your strong connection to our community and if successful you will be required to
 present a Certificate of Authenticity for your artwork (meaning the artwork has been made
 by an Aboriginal or Torres Strait Islander person).
- A response to demonstrate how the piece addresses the ChangeFest 2024 brief:
 - o Reflects our place
 - Celebrates our community's identity and connection
 - o Encompasses our children, young people and families
- Any other documentation that supports your Expression of Interest
- An artist bio
 - o include a bit about you, your country and connection to the local community
 - o This will be used in ChangeFest promotions about you and your artwork
- Artist's statement
 - Tell us about the piece, the relevance and connection of the piece to the ChangeFest brief
 - o Please include a between 150 200 word paragraph about the artwork.
 - Here is an example from Caleb Nichols from ChangeFest23

Caleb's artwork is symbolic of kutalayna/Jordan River flowing through Country. Carving through Country and out to timtumilli minunya/Derwent River where it mixes with the salty waters. This waterway has and always will be significant for our mob as a meeting and gathering place. It provides food, fresh water and cultural resources for our people. The layering of the lines and details represents our deep knowledge and the layers of this knowledge both within Country and ourselves. The circular shapes are our tracks as we travel Country.



- For the submission, a photograph, digital render or sketch and colour samples of the artwork is required.
- Submit by 5pm 30 October 2023

Process and timelines

Expressions of Interest are to be submitted by 5pm 30 October 2023 to hello@handsupmallee.com.

An appointed panel will review the applications and make the final decision.

30 October 2023 Close of Expression of Interest.

All applications must be received by this time to be considered.

31 October- Judging by panel.

3 November 2023

6 November 2023 Selected artist advised.

10 November 2023 Completed artwork submitted by this date. Completion and signature of

licencing agreement.

28 November 2023 Public announcement of selected artist.
